



What is Seasonality and How Can You Benefit from it?

Seasonalities are regular and predictable patterns that recur every calendar year.

Every industry exhibits unique seasonal trends, based on solid fundamental drivers that we are able to benefit from. The best-known seasonal drivers include harvest periods, the timing of interest

payments, the weather, investor sentiment at certain times of the year, tax and balance sheet deadlines, annual or quarterly financial reports, as well as traditional patterns, such as the year-end rally in the stock market. Seasonal strategies generate large gains based on statistical information; emotions play no role in trading decisions.

After many years of intensive research, Seasonax Capital has developed an equity trading strategy that captures seasonal trends in specific stocks and profits from their recurring nature over the course of the entire calendar year.

Challenge

In order to **benefit** from seasonal patterns in the course of an entire year, a sufficient number of statistically profitable **investment opportunities** has to present itself at any given time. The most widely known **seasonal trends** occur only over a limited number of time periods in the course of a year. In order to broaden the number of **investable signals** to the degree needed to be able to **invest at all times**, it is necessary to:

- Evaluate a large amount of historical data on every single stock
- Create algorithms to identify seasonal patterns

Not only stock indices display seasonal patterns, but also individual stocks – and in many cases they occur in different time periods in the course of the year (**highlighted** in charts below).

Single stocks exhibit distinct seasonal trends

By shifting funds between different stocks based on the timing of their strongest seasonal trends, it is possible to generate very large cumulative gains.





Strategic Approach

Individual stocks exhibit distinct seasonal patterns, either due to **internal business reasons**, or due to a variety of **external factors** which **affect their prices**.

By screening different stock indices, we are able to identify and evaluate these **single stock patterns**. This enables us to switch from one stock to the next, exploiting the timing of the respective **favorable seasonal trends** and reap the benefits from the associated outperformance.

Focusing on the **strongest seasonal periods in specific stocks** in the course of the year will result in **compounding profits**.

BACKTESTING: THE SELECTION APPROACH

For a universe such as the constituents of the **STOXX Europe 600 Index**, the seasonality of each stock with a history of **10 years or more** has been calculated. Over the test period of up to 20 years and more, an examination of the seasonal patterns is carried out **every month**.

Stocks displaying favorable trends and returns from a seasonal perspective are included in the portfolio, all others are excluded.

Backtesting is affected by additional factors, such as **selection bias**, **rebalancing** and **equal weighting**.

BACKTESTING METHODOLOGY

In the field of seasonality, the unique combination of:

- **walk forward testing** and
- **completely out-of-sample data sets**

generates extremely robust results. Moreover, the large number of signals reduces the probability that the results are achieved by chance.

The approach works in **different market environments** (bull markets, sideways trending markets, bear markets), **regions** (from west to east), **sectors** (standard stocks, sector-specific stocks) and **eras** (even before internet and news-feeds became available.)
